This serves to certify that the Maine Coon cat/kitten listed was bred by Nucoonrizzn cattery. The cat is guaranteed by the breeder to be a purebred Maine Coon eligible for registration in CFA (The Cat Fanciers Association). The breeder guarantees the cat/kitten is in excellent health at the time of purchase, and is free of parasites, fungus infection, viral or bacterial disease. This cat was examined by a licensed veterinarian on _____. The buyer must agree to have this cat/kitten examined by their veterinarian within 48 hours of purchase, and advise the breeder of the results of the exam. Failure to do so will make this health guarantee null and void. If buyer's veterinarian, upon initial examination to cat/kitten determines that illness or defect was present prior to sale the buyer will provide a written report signed by the examining veterinarian, to include diagnosis and test results to breeder. The breeder should be contacted before any major treatment is begun (unless in an emergency). The buyer may elect within 2 days of the veterinary diagnosis to cancel this contract, return cat/kitten, and will be refunded purchase price, or they agree to accept a replacement when available. Any claims of disease, infection, fungus or parasites cannot be made after cat/kitten has been exposed to a new environment, and to animals. Thus, the need for veterinarian exam within 48 hours of receipt. Prior to exam, breeder request buyer to isolate cat/kitten from other animals. Cats/kittens may show signs of stress when introduced to their new home such as, but not limited to sneezing, runny nose or eyes, diarrhea or constipation. These symptoms can be minimized by the buyer continuing with same diet as breeder and by providing bottled water.

Spay/Neuter agreement:

Buyer agrees to have cat/kitten surgically altered by _____. For pets, and show alters registration papers will be withheld until breeder receives verification from licensed veterinarian of surgery for the alteration.

Additional Agreements:

1. This cat/kitten will not be used for breeding.
2. This cat/kitten will not be declawed.
3. This cat/kitten will not be allowed outside unless in a completely enclosed run.

4. The buyer agrees to keep all vaccinations current, and insure all injections are given in extremities only.
5. This cat/kitten will be kept clean, and well groomed, and free from fleas, worms, and ear mites. Buyer is encouraged to contact breeder if they have questions about bathing, nail clipping, etc.
6. Buyer agrees to provide for this cat's welfare for as long as it lives. If buyer is unable to keep cat/kitten, buyer will contact breeder to allow first right of refusal before placement elsewhere. This cat/kitten will under no circumstance be sold, leased, or given to a pet shop, humane shelter, or research lab, or to any place resembling the previous mention.
7. This cat/kitten will always be provided proper diet and ample supply of fresh water. ie changed daily.
8. This cat/kitten will be kept in a comfortable environment with clean litter and access to a view of the outside. At no time will this cat/kitten be caged for extended periods of time. If confinement is necessary due to illness, enough room would be made available for the comfort of cat/kitten
9. Buyer will agree to provide Susan Norbury updates on cat/kitten through out its life. To share an occasional photo, e-mail and or phone call. Buyer also agrees to allow Susan Norbury or a representative of Nucoonrzn cattery to visit cat if breeder would request such a visit.
10. Buyer will agree to give this cat/kitten lots of love and attention, along with frequent chin scratching, and head butts.
11. If buyer is guilty of repeated or significant violations of the above provisions buyer will agree to surrender ownership of this cat/kitten back to Nucoonrzn cattery without compensation.

At no time shall the liability of the breeder exceed the purchase price of cat/kitten.
